2019 SCHOLARSHIP INSTRUCTIONS

SCHOLARSHIP AMOUNT:

Watsonville Hospital Federal Credit Union will award a minimum of 6 scholarships in the amount of \$500.00 and 2 scholarships in the amount of \$1,000 to students currently enrolled or planning to enroll as a full or part-time student at an accredited college, university, community college or recognized technical or trade school. We will also be offering 1 scholarship in the amount of \$500.00 to any member over 30 returning to school.

DEADLINE:

Watsonville Hospital Federal Credit Union must receive completed scholarship applications and essays **by the close of business on May 28, 2019. Late submissions will not be considered.**

ELIGIBILITY REQUIREMENTS:

- 1. Applicants must be a current primary (not joint) member on a Watsonville Hospital Federal Credit Union account as of the scholarship application date and at least a high school freshman.** In addition, the applicant's account must be in good standing as of the scholarship award date.
- 2. Applicants must be accepted to or currently enrolled at an accredited college, university, community college or recognized technical or trade school as a full or part-time student (with a minimum of 9 units) at the time the scholarship is awarded. (except for high school freshmen, sophomores and juniors)**
- 3. Applicant must have a minimum overall grade point average of 2.5 or above.**

APPLICANTS MUST SUBMIT EACH OF THE FOLLOWING:

1. A completed and signed scholarship application
2. A recent photo and a signed media release form (see page 2)
3. A copy of the last report card or transcript with GPA
4. Provide an essay response to the following:

Scholarship applications and essays will be reviewed and judged by the credit union board of directors. \$500 scholarships will be awarded by a random drawing from all applicants. There will be two \$1,000 scholarships awarded and the winners will be judged and selected by the credit union board of directors. Scholarship winners will be announced at our annual membership meeting(TBA). For currently enrolled students, scholarship funds will be immediately available. For winners who have not yet begun school attendance, scholarship funds will be deposited in to a share certificate earning the highest dividend rate being currently paid by the credit union until their planned date of admission.
